"Small dwelling" means the premises of a self contained dwelling either –
 (a) commonly known as a flat, service flat, home unit or the like, or
 (b) which is contained in a separate strata title.

You are required to notify the Registrar as soon as practicable if:

- The place at which the dog is usually kept is changed
 - The dog has been missing for more than 72 hours
 - The dog dies
 - The ownership of the dog is transferred to some other person
 - A control or destruction order is in force or is made in relation to the dog
- If ownership of the dog is transferred to another person you are required to:**
- Notify the Registrar in writing
 - Give the new owner the dog's current registration disc and certificate of registration
 - Advise the new owner of any control or destruction order made in relation to the dog
