SUMMARY

This report is to update and inform the Alwyndor Management Committee (AMC) regarding items, initiatives and issues of relevance to Alwyndor business specifically and to the aged care sector more generally.

RECOMMENDATIONS

REPORT

Environmental scanning

7.1.1 Royal Commission into Aged Care Quality and Safety (the Commission) update

The final report of the Commission was made public on Monday 1 March 2021.

The report is comprised of 8 volumes with Volume 1 forming the Summary and Recommendations. There are 148 recommendations. The link to this volume can be found on the *Royal Commission into Aged Care Quality and Safety* website.

The media response to the report following its release sensationalised many of the distressing stories which have been highlighted through the 2 years of Commission hearings and evidence gathering.

The sector analysis is ongoing with a focus on the impacts of the report across all areas. Most significant is the discussion and conjecture regarding the support which the aged care industry may receive in response to the report ie what is the cost of implementing the recommendations.

At this stage we know that we will receive an additional \$10 per resident per day (this is outlined in item 8.3: Draft Alwyndor 2020-21 Budget). We also know that Community Care will take a new form and we have submitted an Expression of Interest to participate in the

Single In-Home Care Program data study to help inform the development of the Assessment, Classification, and Funding (ACF) model which will underpin the proposed new Single In-Home Care Program. Debate will continue for some time yet regarding the future of the Residential Aged Care Deposit (RAD) and Daily Accommodation Payment (DAP) elements Residential Care funding.

Australian National Aged Care Classification (AN-ACC)

Progress continues toward the assessment of the funding model (AN-ACC) as a potential replacement for the Aged Care Funding Instrument (ACFI).

The stated aims of the AN-ACC model are to:

- make funding for residential aged care fairer and more stable
- improve the assessment process for funding so it is more accurate and nationally consistent
- remove the paperwork burden on aged care providers and their workers so they can spend more time on providing safe and effective care.

This assessment (known as 'shadow assessment') will commence in April 2021. The Access Care Network Australia (ACNA) have been allocated as the not-for-profit provider who has been allocated to manage the shadow assessment for Alwyndor and we will update AMC as this process rolls out.

No other funding arrangements are clear at this stage and we look forward to the Federal Budget release on 31 May 2021 which is expected to offer greater clarity (and surety) regarding funding for the sector to deliver the sweeping and wide reaching recommendations.

7.1.2 COVID-19 update

Emergency Directions

We continue to work consistent with the requirements of the Federal Government and the Aged Care and Quality Commission and South Australian Emergency Directions for Residential Care 1-12. Four (4) new Directions have been issued since the February 2021 AMC meeting with Emergency Management (Residential Aged Care Facilities No 33) (COVID-19) Direction 2020 issued on 11 March 2021 and now in place.

Throughout these directions the key matters continue to be:

- PPE (specifically requirements for all employees and visitors to wear surgical masks which lifted 23 December)
- visiting restrictions which continue to vary in response to the rolling border closures
- all visitors continue to be required to show evidence of influenza vaccination, have temperature checks and respond to health questions
- single site employment restrictions for personal care workers: is still encouraged for
 personal care, employees working at other sites in roles other than personal care must
 disclose to their employer. Whilst we understand some multi-site providers are sharing
 staff across sites we currently continue to require employees providing personal care
 services to work only at Alwyndor.

There have been no changes to our practices in response to COVID-19.

Vaccinations

COVID-19

We have not yet been notified of the date(s) for our COVID-19 vaccinations. SA Health have not been able to offer any additional guidance around timelines, our plans are in place and we will respond when notified.

Influenza

Initial staff vaccinations due to be delivered this week (w/c 22 March) with the balance in the next two weeks, we will commence the roll out immediately.

Vaccinations are being ordered for residents on 30 March 2021. At this stage it is envisaged that the influenza vaccinations will take place first with the 1a COVID vaccinations to follow at least four weeks later however noting a final date is yet to be confirmed as noted above.

7.1.3 Serious Incident Response Scheme (SIRS)

As advised previously, the new national Serious Incident Response Scheme commences on 1 April 2021.

SIRS requires residential aged care facilities to self-report certain types of incidents to the Aged Care Quality and Safety Commission via an online portal.

Points of note:

- In addition to the existing requirement to report on unreasonable use of force, unlawful sexual contact, and unexplained absences we will now be required to report on:
 - Psychological/Emotional abuse
 - Unexpected death
 - Stealing or financial coercion
 - Neglect
 - o Inappropriate physical or chemical restraint.
- The discretion regarding reporting an incident of unreasonable use of force or unlawful sexual contact has been removed. This means that in the case of a resident dispute or altercation (including in the case of those with cognitive decline) a SIRS report would be required.
- SIRS incidents with a physical or psychological impact on residents are required to be reported within 24 hours. From 1 October 2021 all SIRS incidents, regardless of impact to resident, are required to be reported within 30 days.

We have implemented a training module (45 minute online) for all residential staff. This includes information on identifying abuse and other serious incidents and outlines the actions to be taken.

We have combined the SIRS into our critical incident framework for reporting and managing the incident categories and will report on each type with our quarterly critical incident KPI. We are currently finalising a review of associated policy and procedures to ensure a strong and cohesive response to the changes.
