BACKGROUND

The Santos Tour Down Under was first held in 1999 and has grown year on year to become the biggest cycling race in the southern hemisphere. The week-long event brings the top World Tour professional cycling teams to race on the streets of Adelaide and regional South Australia each January.

Council's relationship with the race spans many years with several stage starts and one full leg stage. Additionally, many associated events organised by third parties to coincide with the race have taken place within the City of Holdfast Bay.

The Women's Race has been elevated to Union Cycliste Internationale World Tour event for 2023.

REPORT

The Santos Tour Down Under Women's race will commence in Glenelg as a Union Cycliste Internationale (UCI) Women's World Tour event – the top level of road cycling competition. Elite international teams and riders compete across South Australia in a three-stage race from 15 to 17 January 2023. The same peloton will also take part in a city criterium on 14 January 2023.

The Glenelg Stage One Santos Tour Down Under Women's race will be the first event of the year on the UCI Women's World Tour calendar, while the Men's event kicks off the UCI World Tour season.

Elevation to the UCI Women's World Tour will offer fans another reason to holiday in our City and support the visitor economy.

The Santos Tour Down Under Women's race began in 2016 and maintained its initial UCI 2.2 status until 2020, when it joined the UCI Pro Series. In 2018 it became the first cycling event in the world to offer women the same prize money as men.

A place on the UCI Women's World Tour means an increase in the coveted season points available to the international teams and riders taking part.

This reinforces the City of Holdfast Bay's strength in hosting major sporting events and our commitment in increasing both visitation and expenditure.

BUDGET

The \$10,000 is within scope of the existing TDU Budget, this covers the host fee and logistic associated costings.
