RECOMMENDATION

REPORT DETAILS

Background

Council allocates a significant budget to the replacement of kerb and watertable and footpaths.

Many Councils contract major construction works to private enterprise on the basis that quantities of scale and competitive tendering, in the main, generate better outcomes than can be realised using in house labour, materials and machinery.

Also noted was that private enterprise and contractors are able to make a profit on works such as these carried out on Council's behalf. With this in mind the question was raised if Council could undertake these works themselves generating a cost saving which would in turn be passed onto Council. Whilst on the surface this could be seen as sound reasoning, extra thought would need to be given to the extra staffing and machinery and equipment required to undertake all Council's yearly kerbing and footpath project works.

Previous reports and decisions

Council has not considered this issue before.

Key issues discussion

For many years Council has undertaken major construction works utilising contractors engaged through a public tender process. Normally under a three year contract.

Whilst Council doesn't routinely bench mark with other like entities, good governance would dictate that from time to time we should compare our service providers with others in the industry. On this basis we have enlisted the support (on a confidential basis) of some of our peers in local government.

In the past financial year Council has constructed approximately 4,500 lineal metres of kerb and watertable and 15,000 square metres of footpath brick paving.

To undertake this work "in house" would require a significant increase in employee numbers plus Administration support, staff and machinery.

Financial sustainability impact

Budget

There are no implications on Council's budget generated by this report.

Full life cycle costs

There are no full life cycle costs emanating from this report.

Conclusion

With the information gathered from other Metropolitan Councils it can be seen that the City of Holdfast Bay footpath construction along with kerb and watertable replacement costs are very competitive when compared to other metropolitan Councils. More research would need to be conducted into labour and machinery requirements should Council ever consider undertaking these construction projects using "in house" resources in the future.
