Increasing regulatory and reporting requirements as well as the pending funding and service models were discussed. The General Manager noted that these have been raised at a national level through LASA.

Continuous Improvement (CI) Plan update:

The three CI plans which were developed in response to the ACQSC visit in September (Falls, Call bell management and Work force planning and development) are on track to be completed by 30 November 2021. This work, together with update and monitoring of the overarching Alwyndor CI Plan, has been a major focus for the Residential team over the past two months with a significant reduction in call bell and alert response times, updated fall risk assessments for high falls risk residents and continued focus on training and development of employees.
