BACKGROUND

The Tour Down Under was first held in 1999 and has grown year on year to become the biggest cycling race in the southern hemisphere. This prestigious race brings top men's and women's professional cycling teams to race on the streets of Adelaide and regional South Australia for a week each January.

In 2023, the City of Holdfast Bay hosted the Ziptrak® Women's Stage 1 start at Glenelg on Sunday 15 January 2023, and the Men's Stage 2 start at Brighton on Thursday 19 January 2023.

On 14 February 2023, Council endorsed submitting an Expression of Interest (EOI) to host men's and women's race stage starts again in 2024 (C140223/744).

REPORT

Events South Australia has advised the City of Holdfast Bay that the EOI to host a Santos Tour Down Under Women's race has been successful. The details that have been provided are as follows:

Date: Saturday 13 January 2024 Stage: Women's Stage 2 (start)

Location: Glenelg Hosting fee: \$0 in 2024

This information has been provided in confidence in advance of the public announcement of the race routes, anticipated to take place on Friday 23 June 2023.

At the time of writing, no advice had been received regarding the outcome of the EOI to host a men's stage start.
