

BEACH CONCERTS

Pursuant to Section 83(5) of the Local Government Act 1999 the Report attached to this agenda and the accompanying documentation is delivered to the Council Members upon the basis that the Council consider the Report and the documents in confidence under Part 3 of the Act, specifically on the basis that Council will receive, discuss or consider:

b. Information the disclosure of which could reasonably be expected to confer a commercial advantage on a person with whom the council is conducting, or proposing to conduct, business, or to prejudice the commercial position of the council; and would, on balance, be contrary to the public interest.



Recommendation – Exclusion of the Public – Section 90(3)(b) Order

- 1 That pursuant to Section 90(2) of the *Local Government Act 1999* Council hereby orders that the public be excluded from attendance at this meeting with the exception of the Chief Executive Officer and Staff in attendance at the meeting in order to consider Report No: 321/19 Beach Concerts, in confidence.
- 2. That in accordance with Section 90(3) of the Local Government Act 1999 Council is satisfied that it is necessary that the public be excluded to consider the information contained in Report No: 321/19 Beach Concerts on the following grounds:
 - b. pursuant to section 90(3)(b) of the Act, the information to be received, discussed or considered in relation to this Agenda Item is information the disclosure of which could reasonably be expected to confer a commercial advantage on a person with whom the Council is conducting business; would prejudice the commercial position of the Council.

In addition, the disclosure of this information would, on balance, be contrary to the public interest. The public interest in public access to the meeting has been balanced against the public interest in the continued non-disclosure of the information. The benefit to the public at large resulting from withholding the information outweighs the benefit to it of disclosure of the information.

3. The Council is satisfied, the principle that the meeting be conducted in a place open to the public, has been outweighed by the need to keep the information or discussion confidential.

The City of Holdfast Bay in conjunction with Zaccaria Concerts and Touring will host four beach concerts on the Glenelg foreshore, north of the jetty, with the public announcement embargoed till the dates outlined in the report below.

Concert: 7 December 2019 - Tash Sultana

Tash Sultana, an Australian singer songwriter and multi-instrumentalist is an explosive live artist who has commanded global attention since homemade videos went viral. Tash was soon selling out major arenas globally and playing at the world's biggest festivals – no mean feat for an artist who just a year before was recording songs on a go pro in a bedroom. Sultana's 2016 single "Jungle" was voted into third place in the Triple J Hottest 100, 2016.

International sensation Fatboy Slim is an English DJ, musician, and record producer who helped to popularise the big beat genre in the 1990s. He is a multiple winner and nominee of international awards including Grammys, MTV Music Awards, Teen Choice Awards, World Music Awards and Brit Awards. He has also played at major music festivals including Glastonbury, Coachella and Good Vibrations and has also performed at many beach concert locations around the world. Some of his most known works include "Praise You" and "You've Come a Long Way, Baby".

Zaccaria Concerts and Touring have secured Australian music legends Cold Chisel. Cold Chisel are an Australian pub rock band, which formed in Adelaide in 1973.

At the ARIA Music Awards of 1993 they were inducted into the Hall of Fame. In 2001 Australasian Performing Right Association (APRA), listed their single, "Khe Sanh", at No. 8 of the all-time best Australian songs. Circus Animals was listed at No. 4 in the book, 100 Best Australian Albums (October 2010), while East appeared at No. 53. They won The Ted Albert Award for Outstanding Services to Australian Music at the APRA Music Awards of 2016.

Adelaide born and raised Paul Kelly has been acknowledged as one of Australia's best singer-songwriters. His music style has ranged from bluegrass to studio-oriented dub reggae, but his core output comfortably straddles folk, rock, and country. His lyrics capture Australia's vastness both in culture and landscape; he has chronicled life about him for over 30 years and is described as the poet laureate of Australia.

General Information

The concert site will utilise the new layout that Council have previously been advised about for the Castaway Beach Concert, 3 January 2020.

Administration will share the event information post the public announcement on the Council website, through social media and media release.

- Gates open at 1.00pm
- Live Music Commences at 2,50pm
- Music Finishes at 10.00pm

Administration will distribute a notice to residents and nearby businesses (Platinum Apartments, Glenels Surf Club, Beachouse, Boomers, Marina Pier office, reception at Oaks and properties south of the jetty) approximately 2 weeks prior to bump in.

Closer to the event Elected Members shall receive communications around confirmed timings which include sound check and other key event information.

Objectives
