State Opera South Australia (not being an employee of the Council, or a person engaged by the Council), has requested this information to remain confidential

In addition, the disclosure of this information would, on balance, be contrary to the public interest. The public interest in public access to the meeting has been balanced against the public interest in the continued non-disclosure of the information. The benefit to the public at large resulting from withholding the information outweighs the benefit to it of disclosure of the information.

 The Council is satisfied, the principle that the meeting be conducted in a place open to the public, has been outweighed by the need to keep the information or discussion confidential.

SUMMARY

The State Opera South Australia has offered Council the opportunity to host 'Boheme on the Beach' on Saturday 26 March, 2022 as an event partner.

The 8000 capacity opera is the major production of State Opera for 2021, delivered and produced in a similar format to previous beach concerts. There is the opportunity to share infrastructure with the beach concerts staged the weekend prior, optimising use of existing resources.

BACKGROUND

State Opera South Australia has approached the City of Holdfast Bay to partner in the staging of their annual major production. The highly successful staging of Carmen by State Opera in 2021 in Victoria Square has inspired State Opera to produce 'Boheme on the Beach'. Taking opera from traditional venues to outdoor settings increases atmosphere and appeals to a broad audience, while offering traditional opera consumers a unique experience.

The event will attract arts festival and music audiences, families, and large numbers of first-time opera patrons keen for a unique cultural experience.

The success of the beach concerts such as the SummerSalt, Castaway and By The C events has given State Opera the confidence to stage on Glenelg beach with support across council including marketing and communications, tourism development, Jetty Road support, depot expertise and event delivery.

Set under the stars on Glenelg Beach, this one-night-only special event presents Puccini's iconic opera *La bohème* against a stunning natural backdrop of the beach at sunset.

Presented by State Opera South Australia and featuring top Australian operatic talent with the State Opera Chorus and the Adelaide Symphony Orchestra. This event will be an unforgettable "you had to be there" cultural experience on the beach.

STRATEGIC ALIGNMENT

Staging an artistic performance of this calibre aligns with both the City of Holdfast Bay's Events Strategy and the Creative Holdfast Arts and Cultural Strategy.

ECONOMIC IMPACT

The anticipated economic return for the City of Holdfast Bay of hosting of Boheme on the Beach is estimated at \$800,000 however, the legacy impact would continue for some time.

Risk Assessment

 Potential exposure to complaints by external parties including residents and regular beach users pertaining increased activity, accessibility, COVID restrictions and noise levels.

Risk Mitigation:

External communique conducted at least two weeks prior to ensure residents are informed. Regulatory Services to brief inspectors to approach dog walkers and beach goers advising of event details in addition a public notice will be placed within various publications to ensure beach users, residents, businesses and the broader community are informed.

Further Risk Management Plans for the overall Risk Management Plan developed covering:

- Fire: General, Catering, Electrical, Explosion, Hazardous Materials, Vehicular;
- Accidents: Structure Collapse, Structure Falls, Manual Handling and Lifting, Slips, Trips and Falls, Vehicular;
- Medical: Trauma Injuries, Minor Medical, Forgotten Medication, Dehydrations, Drug and or Alcohol Affected Persons, Respiratory Aliments;
- Security: Bomb Threat, Crime (Public), Crowd Management, riot, Vandalism, Cash Handling, Unauthorised Access, Climbing of Structures;
- Health and Safety: Evacuation, Sexual Assaults, Drink Spiking;
- Utilities: Ablutions Failure, Power Failure, Waste Management;
- General: Noise Pollution, Hazardous Spill or Leak;
- Weather: Electrical, Wind, Hail and Thunderstorms, Flood; and
- COVID Safe Management Plan.

BUDGET AND SUPPORT

State Opera South Australia seeks the following in-kind support from the City of Holdfast Bay

- Local Promotion street flags, signage, concessions, media opportunities;
- Interstate Marketing tourism packaging;
- Liaison with Holdfast Bay Promenade Residents (Oaks Glenelg Plaza Pier) and securing of back-of-house spaces;
- Engineering Assessment;
- All permits, local licenses, public notices;
- Traffic Management planning, staffing, signage and regulatory approval; and
- Site preparation pre event and remediation post event.

Estimate \$3000 - \$5000 be absorbed from within existing City Activation and Events budget.
