5.5 TDU Street Party (verbal update)

The TDU Street Party took place on Wednesday 18 January. Over 52 traders took part in this year's event and the estimated attendance was over 40,000. That is an increase of 15,000 from last year. Independent market research took place on the evening and the full results will be shared in a debrief report at the next meeting. SAPOL reported no incidents and St John's had 3 minor presentations.

# 5.6 Glenelg Sunset Markets (verbal update)

Manager, Jetty Road Development advised that the first Glenelg Sunset Markets took place on Sunday 29 February. This is a collaboration between Gilles Street Markets, City of Holdfast Bay and JRMC. Although the weather was extremely hot, the markets were very well attended by the public. Stall holders feedback stated that it was a success financially for them. 50 stall holders set up for the first market and the event organizer has advised that she has received requests from 80 stall holders to take part in the next event. The events team, along with Manager, Jetty Road Development will work through the logistics for the increase in number of stalls.

5.7 Glenelg Masterplan (next steps)

Manager, Jetty Road Development advised that the tender had been completed and that Oxigen Pty Ltd had been appointed.

A workshop will be held in the next month or so with Oxigen Pty Ltd and JRMC to discuss the masterplan.
