Members are reminded that a right of access under Section 61 does not eliminate the responsibility to consider both the conflict of interest provisions of Section 73 of the Local Government Act or the general duties set out in Section 62 (3), which provide that:

"A Member .... must not, ... make improper use of information acquired by virtue of his or her position as a Member of the Council to gain, directly or indirectly, an advantage for himself or herself or for another person or to cause detriment to the Council".

Furthermore, Members are reminded that Section 251 of the Criminal Law Consolidation Act provides penalties for improper use of information gained by virtue of public office.

### 16.2 The Dublin Irish Pub – Liquor Licence Variation (Report No: 56/06)

Report No: 56/06 was presented advising that an application seeking extended trading authorisation and entertainment consent for The Dublin Irish Pub, 11 Moseley Street, Glenelg has been lodged with the Office of the Liquor and Gambling Commissioner.

While certain aspects of the application are considered acceptable, the proposed changes to Sunday (Monday morning) trading are at variance with Council's Liquor Licence Policy and therefore Administration recommends that Council not support this aspect of the licence application.

- 1. That the Office of the Liquor and Gambling Commissioner be advised that Council does <u>not object</u> to the proposed trading hours for The Dublin Irish Pub for Good Friday, Christmas Day, Christmas Eve, days preceding Public Holidays and Sundays preceding Public Holidays.
- That the Office of the Liquor and Gambling Commissioner be advised that Council does <u>object</u> to the proposed extension to Sunday trading hours for The Dublin Irish Pub on the basis that:-
  - The proposal is at variance with the Council's Liquor Licence Policy; and
  - The extension will encourage the movement of patrons between licensed premises in the early hours of the morning, resulting in potential public disturbance, property damage and residential amenity nuisance.
- 3. Should the Office of the Liquor and Gambling Commissioner propose to support the application from The Dublin Irish Pub to extend its trading hours, Administration be authorised to take all necessary steps to oppose any such move.
