# 15.2 Bay Discovery Centre – Air Conditioning Upgrade (Report No: 83/06)

Report No: 83/06 was presented advising that the Bay Discovery Centre air-conditioning plant has been an issue of concern since the initial creation of the Centre five and a half years ago. In 2003 a quotation to upgrade the air conditioning plant within the Glenelg Town Hall complex was obtained and Stage 1, being the upgrading of air conditioning to the Mayor's Parlour and Council Chamber was approved. Further stages of that renewal program have not been funded in the subsequent years budgets.

This report recommends that Council allocates the net amount of \$41,200 towards the urgent replacement of the Bay Discovery Centre air-conditioning plant.

- 4. That further information be sought from the SA Fisheries Department and SA Surf Life Saving Association of South Australia Inc. to confirm the extent of any shark fishing activity, any assessment of resultant increase in risk to public safety and any measures that the State Government proposes to take in relation to this issue.
- 5. That Council further consider its position on this matter after the receipt of responses from the State Government to both (4) above and Council's previous correspondence o the issue of shark nets or barriers.
