Glenelg foreshore is a popular area that is used for passive and active recreation and special events. It includes the linear park known as Jimmy Melrose Park along the foreshore and the forecourt area in front of the Glenelg Jetty. It includes shared walkway/cycling and walking only paths, large grassed areas, large pine trees, landscaping, a wall separating the beach from the reserve, park furniture, public art, monument, toilets and the Broadway Kiosk.

Given that the proposed lease is for a period of greater than 5 years, that the lease initiative is consistent with the objectives specified in the Community Land Management Plan, and in accordance with Council's Public Consultation policy, the proposed lease was advertised in the Messenger Guardian on 8 February 2006.

(Elected Members were advised of the proposal to seek public comment regarding the proposed lease in an EM Bulletin which was issued on 2 February 2006.)

The public was provided with the opportunity to make comment on the proposed lease (comments to be received by no later than 1 March 2006). Whilst a number of copies of the draft were distributed to interested parties (upon request) no comment was received by Council Administration during the relevant period. This was advised to Council on 28 March 2006 (refer report 158/06 which went to Council).

# 6.2.2 Confidentiality of Council discussions

- 4. Following the release of confidential reports or minutes are Elected Members or staff present during the confidential meeting entitled to convey the discussion (debate) of what other fellow Elected Members said whilst in confidence to third parties?
- 5. Is it appropriate for an Elected Member to discuss a complaint for breach of code of conduct with third parties when Council's Executive has considered the matter and the executive resolved and declared the matter confidential on the basis "the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of a person or persons (living or dead) under Section 90(2) and 90(3)(a) of the Act?"

# **General Manager Social and Organisation response**

As it is proposed in this agenda (item 16.2) to invite our legal advisor to attend an informal gathering of Elected Members on 12 September 2006, with Council's support, it is suggested that these questions form part of that discussion.
