As the question doesn't specify which budget (Original/Adopted) or which Surplus/Deficit (including excluding capital/extraordinary items etc), Administration has asked for the original budget for each year as well as the operating surplus/deficit excluding capital and extraordinary items. But, the original budget could be very different form the final revised budget and/or the actual position depending on how conservative or prudent each council is in setting its budget as well as what decisions are made during the year.

The councils listed above vary greatly in size. There is little value in directly comparing a deficit/surplus for Marion, West Torrens or Onkaparinga with Holdfast Bay.

The consolidated operating result for City of Holdfast Bay is actually \$660k in surplus. The 'deficit' of \$285.5k relates to the break out of City of Holdfast Bay figures, excluding Alwyndor. This is somewhat of an anomaly when you consider this is a one year budget but it supports funding long term assets (eg King Street Bridge, Coast Park, Seacliff Surf Club) all with 30-50+ year life spans. This is a multi-generational benefit and therefore funding. On that basis it is considered a budget that adds significant community value. Also, last year we contributed \$300k to the Brighton Performing Arts Centre. That alone (if avoided) would knock out the debt. So would an extra 1.3% of rates. So would one-offs, like \$200k paid for a 4 yearly election etc. One could contend that the benefits gained through new initiatives in 2010/11 warrant the deficit situation, which was created by fixing the rates at 4%. Next year we would expect a return to a balanced budget which, depending on Council's funding decisions is always our goal. The underlying financial position of Council remains both sound and sustainable.
