BACKGROUND

Wollongong Council has decided to write to the Prime Minister and urge him to consider the threat of human-induced climate change and its potential impact on coastal infrastructure and residents, also to request the subject is put on the G20 agenda for discussion of these wide-ranging consequences.

Considering our recent efforts and the costs agreed for the Resilient South project, it would be appropriate if we also write to the Prime Minister regarding this.

Climate change has been identified by many agencies as a major economic threat. We note that the International Monetary Fund, the Committee for the Economic Development of Australia, and the US G20 emissary Caroline Atkinson, have this year all called for climate change to be on the G20 agenda. We also note that a recent report, Strategy 2020, from the Asian Development Bank has identified climate change as a major threat to economic growth in that region. To quote their website "in line with its Strategy 2020, ADB is integrating climate change into its planning and investment to ensure continued economic growth and a sustainable future for all in Asia and the Pacific." Therefore it seems apparent that having climate change on the agenda is consistent with the second of the key themes you have set for the November G20 meeting, viz "making the global economy more resilient to deal with future shocks."

BACKGROUND

The residents who live between Alfreda Street and King George Avenue only have rear access to their properties and there is nowhere for visitors, tradespeople or the residents to park on The Crescent. The matter has been raised with Administration and I believe that it needs to be done formally as the residents need a response to their request.

14.2 Cotto – Application for Restaurant Liquor Licence (Report No: 282/14)

A new café, 'Cotto' (Cotto F&B Pty Ltd), is set to open in shop 3 Moseley Square Glenelg. COTTO is an Italian style espresso bar/café and like the Adelaide, Hyde Park and Woodville locations, the Glenelg store will serve premium coffee and offer a café style menu complete with Italian style breakfast, pastries, sweets, pizzas, focaccias and baguettes. As part of the café's establishment the proprietors are seeking to obtain a Restaurant Liquor Licence which will permit the licensee to provide liquor to customers in addition to food and beverage services.

As part of the Restaurant Licence application the applicant is also seeking: an Extended Trading Authorisation (ETA) for Sundays (only) that in conjunction with Council Liquor Licensing Policy will permit the licensee to provide liquor Sunday to Thursday until 12:00midnight, Friday and Saturday until 1:00am the following morning; a standard section 69 approval to serve liquor in the outdoor dining area; and a section 34 (1) (c) exemption which will allow the licensee to supply liquor to a patron seated at a table without the provision of a meal.

Development Application 110/0201/14 was approved on 16 April 2014 and the shop fit out and works has commenced. As this application is in line with Council's current Liquor Licencing Policy (2011), and does not contravene any development issues it is recommended that Council endorse the proposed liquor licence and associated conditions.

The applicant is now seeking Council endorsement prior to lodging an application with Consumer and Business Services.

That Council advise Consumer and Business Services that it supports the approval of a Restaurant Liquor Licence to sell and/or supply liquor in accordance with section 34 (1) (a), (b) & (c) of the Liquor Licensing Act 1997, subject to the following:

Restaurant Liquor Licence – Section 34:

1. **That the hours of liquor service for all internal areas cease:**
 - a) **Sunday to Thursday 12:00 midnight the same day;**
 - b) **Friday and Saturday 1:00am the following morning;**
2. **That the hours of liquor service for any outdoor dining area(s) (approved under section 69 of the Act) cease no later than 12:00pm on any day;**
3. **That the sought section 34 (1) (c) exemption reflect the above hours;**

14.3 **Preliminary 2013-14 Funding Statements and 2013-14 Budgets Carried Forward** (Report No: 285/14)

This report provides preliminary unaudited funding statements for the 2013/14 financial year including explanations of the interim results and major budget variations. The report also includes final details for incomplete projects and programs as at 30 June 2014.

The interim operating result for Council's municipal activities shows an increase of \$661,659 in the forecast operating deficit. Much of this is a result of timing variations including the Commonwealth Government ceasing to prepay the Financial Assistance Grant (\$547,253) and a delay to 2014/15 in receiving the Stormwater Management Grant from the State Government (\$120,000). Further details of all major variances by resource are contained within this report.

The interim operating result for Alwyndor operations shows a net increase of \$778,880 in operating costs resulting in a \$409,664 operating deficit. Major budget variances have occurred in user charges, grants and employment costs which reflect the unpredictable nature and demand for the packages offered and additional accreditation costs. The level of government funding and user pay income is also based on the client's income and needs.
