9.2.1 Question on Notice – DPA for Jetty Road and South Esplanade – Height of Buildings (Report No: 190/16)

Councillor Wilson asked the following questions:

- "1. Will council be notifying the residents around Seawall that the DPA for Jetty Road and South Esplanade has without any consultation or notice, been amended to provide that the site will be able to build from 11 storeys South of Saltram Walk graded to 5 on Pier St?
- Can Administration advise how the proposed masterplan for Jetty Road will link in with the new DPA so that a consistency in design can be achieved for the area?"

ANSWER – Strategic Planner Policy

1. The Glenelg District Centre (Jetty Road) and Residential High Density Zone Review Development Plan Amendment (DPA) was a Ministerial DPA.

At the conclusion of the formal public consultation period, a public hearing was held on the DPA and the Government made a number of changes to the Amendment. It is understood that policy changes made following consultation to enable increased building heights at 19 South Esplanade (Seawall apartments site) was in direct response to a representation made at the public hearing on behalf of the site's owners.

Ultimately, the Minister can make amendments to a DPA as a result of consultation, but a judgement must be made as to whether this would constitute a 'substance' change that would require re-consultation. In this instance, it is assumed that the Minister has considered the changes to be minor in the scope of the wider DPA and the Government has not re-notified adjacent land owners of this or any other changes to the DPA.

Consequently, no further notification of changes made to the DPA following consultation has occurred.

 The DPA proposed a number of policy changes which guide the redevelopment of properties and increased residential living opportunities located above commercial development in the Glenelg District Centre.

The Jetty Road Master Plan will primarily seek to provide a framework for the upgrade to the public environment and streetscape in Jetty Road.

While the development of the Master Plan will need to be cognisant of these recent planning policy changes and consider the desired character of the precinct and its buildings as they relate to the public environment, the design of new buildings in the precinct will still ultimately be guided by the Development Plan.

Further, recent changes to the Development Regulations will mean that any building over 4 storeys in the precinct will be subject to a formal design review process by the SA Government Architect and assessed by the Development Assessment Commission.

9.2.2 Question on Notice – Messenger Article on New Tram Tracks on Jetty Road, Glenelg (Report No: 193/16)

Councillor Smedley asked the following question:

- "1. Can you advise the details of DPTI's commitment to the works regarding the tram tracks and the timetable for their completion?
- 2. If DPTI's commitment is of a longer term nature, ie tied to the useful life of the current tracks, given ongoing incidents in the vicinity of the tram stop, could Council approach DPTI with an interim, shorter term solution, that the section of track in front of and to a reasonable distance either side of the current tram stops be either relayed, or perhaps retrofitted with the inlays, as a matter of priority?"

BACKGROUND

I refer to the Guardian Messenger article dated 18 May 2016, entitled New tram tracks set to be laid on Glenelg's Jetty Rd with rubber inlays to improve cyclist safety.

The article advised that City of Holdfast Bay had announced that Jetty Road's tram tracks were to be lifted and re-laid with rubber inlays to improved cycling safety on the street, particularly in the vicinity of Stop 16/21D (North and South) where the road narrows to accommodate the tram stop platform.

ANSWER - Acting General Manager City Assets & Services - Mr K O'Neill

Administration has met with DPTI project managers recently and the key points were:

- A project group between DPTI and the City of Holdfast Bay has been established.
- DPTI would not be able to commence the project before December 2016 due the time required for specification development and planning processes.
- We are reluctant to interrupt the Jetty Rd business during the coming summer season.
- Therefore, the project team is working towards developing a schedule to commence the project in May 2017 so that we could complete the work this financial year.
- There will be a number of key issues that needs resolution during the design phase of the project.
- Cycling safety had been identified as one of the key issues.

- Project management group is determined to identify a solution (which doesn't appear to be easy and no solution had been identified yet)
- The project team will meet on a regular basis from here on.

11. MOTIONS ON NOTICE

11.1 Motion on Notice – Landscaping of Brighton Road (Report No: 189/16)

Councillor Yates proposed the following motion:

BACKGROUND

The recent heat mapping done in Holdfast Bay showed that Brighton Rd, the backbone and major thoroughfare of our city, is a hot spot along its whole length. Landscaping such as was done on Portrush Rd, Norwood with trees and grasses in the median strip would improve the road, preferably with areas of WSUD (water sensitive urban design) to encourage healthy tree growth as well as reduce heat and air pollution.

However, the narrow median strip of Brighton Rd has led DPTI to refuse to allow replanting of trees there when any die or are damaged by traffic. Thus, the whole road now looks very tired and unattractive to the many car drivers stuck in traffic along its length for long periods in the rush hour. What they may remember when Holdfast Bay is mentioned is an old green carpet on the median strip which the roots of surviving trees have pulled up unevenly and 50 or so gaps with no trees that are just bare dirt areas left cut out of the carpet. Areas where moss has covered the carpet look better - at the northern end of the road. The area just south of Edward St looks particularly unattractive as there are 4 gaps in a row there so that the small median strip between road entries is left completely bare. Not a good look for a premier seaside area.

Brighton Rd could be a showcase for Holdfast Bay rather than the unpleasant polluted traffic route it has become. It is time to update it but DPTI needs to be involved in these plans. If trees cannot be planted in the median strip, there must be some suitable greenery that would help alleviate the heat island effect and look more attractive, but it would be preferable if DPTI were persuaded to change its policy on trees.

As a hot spot, it may be possible to get a grant via The Resilient South to green the road more. It needs to be updated and the median strip especially needs attention to make it attractive and reduce the heat island effect of all the bitumen and traffic.

2. Recent storms have felled approximately 10 spotted gums on the eastern side of Brighton Rd - they were unable to develop buttress roots in the small unpaved areas they were planted in, even though provided with flexible rubber surrounds, and so were unstable and could not withstand the high winds. If better planting methods cannot be found for them, it may be sensible to change the street tree listed in the planting strategy to eg plane tree.
