14.2 **Jetty Road Mainstreet Committee Governance Model Business Case** (Report No: 85/19)

The Jetty Road Mainstreet Committee (JRMC) is an advisory committee of the City of Holdfast Bay formed under Section 41 of the *Local Government Act 1999*. At the 7 November 2018 JRMC meeting the JRMC appointed Premier Retail Marketing and Peter McNabb and Associates to prepare a business case that was endorsed by the JRMC at their 5 December 2018 meeting. The Incorporated Association Business Case was presented by Mark Faulkner, Chair of JRMC and David West of Premier Retail Marketing at the 26 February 2019 Council Workshop.
