2022/23 Preliminary Funding Statements, Budget Carried Forward and Activity Reports (Report No: 280/23)

This report provided preliminary funding statements for the 2022/23 financial year including explanations of the interim results and major budget variations as well as detailing yet-to-be-finalised projects to be brought forward and budgeted for in 2023/24. Also presented was a summary of the external grant funding received during the year, as well as a report detailing the organisation's progress in achieving the new initiatives and capital renewal program as set out in the Annual Business Plan for 2022/23.

Following a comprehensive budget review in April 2023 a Municipal surplus budget of \$708,910 was adopted. The preliminary result for Municipal operations shows an operating surplus of \$2,523,667 resulting in a positive budget variance of \$1,814,757 compared with the adopted forecast. Explanations for the major variances are discussed in Attachment 1 to this report.

The preliminary result for Alwyndor operations showed an operating deficit before fair value adjustments of \$778,350 compared with the adopted forecast deficit of \$308,000 resulting in a negative budget variance of \$470,350.

\$1,745,317 compared with the adopted surplus forecast of \$400,910 resulting in a positive budget variance of \$1,344,407.
