12.2 Motion on Notice - Investigation Into Improved Lighting In Gregory Lane,
Brighton - Councillor Bradshaw (Report No: 119/25)

15.2 **Budget and Annual Business Plan Update – as at 31 March 2025** (Report No: 121/25)

This report covered the third update of Council's 2024-25 budget conducted as at 31 March 2025.

A comprehensive review of Municipal budgets has increased the forecast operating surplus by \$1.01 million to a forecast surplus of \$1.31 million. Major variances accounted for include additional grant revenue and savings on budgeted interest costs due to the timing of new borrowings. The savings on interest costs will be used to offset future borrowing requirements. These favourable variances have been offset by an increase in depreciation.

Capital expenditure has been reduced following the reallocation of an \$800,000 project to the operational budget. In line with Australian Accounting Standards this expenditure is now to be classed as an operational cost.

Alwyndor forecast an increase in their operating surplus of \$56,000 to \$633,000 due to various factors including higher residential funding and lower employee costs. Forecast capital expenditure remains unchanged.

Attached were financial reports for Municipal and Alwyndor operations, commercial activities, and progress summaries and analysis of Annual Business Plan projects.



Motion 130525/8046

That Council:

- notes the third 2024-25 budget update for Council's municipal operations including:
 - (a) a movement in the forecast operating result for 2024-25 of \$300,000 from a surplus of \$1.010 million to a surplus of \$1.310 million;
 - (b) a decrease in forecast capital expenditure of \$776,000 from \$40.952 million to \$40.176 million;
 - (c) no change in forecast capital revenue of \$4.559 million;
 - (d) a decrease in forecast net financial liabilities of \$2.177 million at 30 June 2025 from \$48.999 million to \$46.822 million.
- notes the first 2024-25 budget update for Alwyndor operations including:
 - (a) a movement in the forecast operating result for 2024-25 of \$56,000 from a surplus of \$577,000 to a surplus of \$633,000;
 - (b) no change in forecast capital expenditure of \$1.733 million;
 - (c) a decrease in the forecast funding required for 2024-25 of \$105,000 from a funding surplus of \$1.232 million to a funding surplus of \$1.127 million.
- 3. notes the Annual Business Plan quarterly update for March 2025.

15.3 **Heritage Advisory Service** (Report No: 132/25)

Following an investigation into the merits of appointing a dedicated resource for the protection and promotion of the city's built heritage and suburban character, this report found that the existing resourcing of the Heritage Advisory Service is adequate based on current demand and a comparative analysis with other councils. This report did however recommend that consideration is given to additional resourcing in the future following the implementation of initiatives such as the Art Deco Review and Heritage Advisory Committee and based on a needs analysis at the time.

2. Administration undertakes a further needs analysis as to the resourcing adequacy of the Heritage Advisory Service immediately following the establishment of the Heritage Advisory Committee and the completion of the Art Deco Code Amendment.
