Manager, Jetty Road Development advised that initial costings have been received for Winter Wonderland 2015 based on an extended run time of 6 weeks, additional sessions each day and an ice rink twice the size. This will allow for approximately 55,000 tickets to be sold as opposed to 16,000 In 2014.

It is expected that the increase in ticket sales will cover most of the increase cost of running the event. However, there will still be a shortfall and therefore, it is recommended that the JRMMC write to Council seeking co-funding of up to \$75,000, as per 2014.
