5.6 Car Parking Contribution Fund

C220714/1180 **Amendment**

- 1. Reduces the current car parking rate under the Holdfast Bay Car Parking Contributions Fund from \$31,500 to \$7,000 per space.
- 2. Publishes the new rate adopted in the South Australian Government Gazette pursuant to Section 50A(6) of the Development Act 1993 prior to taking effect.

- 3. Review the effectiveness of this policy change in 12 months.
- 4. That the carparking levy not be applied for a change of use from a shop to a restaurant or café where the premises were previously used for that purpose (within ten years of the application for a change of use).

5.7 Term of Current Committee

Manager, Jetty Road Development advised that as Council goes into caretaker mode from early September, a report was submitted to Council at its meeting on 22nd July requesting that the term of the current committee be extended to cover caretaker mode. Council passed the following motion:
